Candidate Statement

This past decade will be remembered for its series of losses and catastrophes – characterized by economic, environmental and political crises. How might we reposition the discipline of Architecture in such a period of limited possibility? Can we redefine our era's challenges as opportunities that reflect upon our current condition, as a means to position positive futures for the discipline of Architecture? We might, for example, look to recent innovations pioneered by the discipline of Landscape Urbanism, which reclaims the potential of abandoned territory by turning what had been previously considered waste lands into productive ecologies. Like our Landscape Urbanist friends, we must recognize possibility in neglected terrain. We might consider that the future of our profession depends on how well we address challenges by designing opportunity.

ACSA, through its knowledgeable leadership and active membership, is well poised to transform the challenges confronting our profession. Architectural education holds the unique ability to foster change by leveraging relationships within its diverse domain. In this sense, architectural education's new terrain is that of expanded practice, one that optimizes the role of design and critical thinking.

The ACSA works to identify the important issues that will shape our profession and provide opportunities to critically address them. Many opportunities lie within the paradoxes of our contemporary culture, like the juxtaposition of rapid globalization and international exchange with grass-roots initiatives and local practices. Opportunities for interdisciplinary collaboration expand professional boundaries, yet we must work to strengthen the autonomy of the discipline,



heightening Architecture's traditional cultural and professional roles. Certainly, there are a host of issues facing the profession that present as possibilities for innovation, including, new media and technology developments that augment communication, representation and reproduction potentials for architecture; and ecological challenges that call for creative means of testing environmental potential. We must also continue to draw upon the rich intellectual and cultural diversity of our faculty and academic programs as we move toward global models of education.

I am honored to be considered for the position of Secretary, to serve ACSA and its member schools at this important time. My past experience as ACSA East Central Regional Director has prepared me well for leadership as Secretary. I welcome the opportunity to work with ACSA to shape initiatives that serve faculty and schools during such challenging times. As we near the forthcoming Accreditation Review Conference, my experience representing ACSA as an NAAB accreditation team member has prepared me to address issues that matter to schools. ACSA is strongest in partnership with collateral organizations that can work together to address forthcoming opportunities.

My own academic experience has prepared me to address a wide range of educational initiatives, from topics of design, representation and fabrication to architectural theory and environmental strategies. I have led interdisciplinary collaborations between Architecture and Engineering, and developed design-build projects when none existed for our students. I have co-directed an international study program; developed academic programs and funding as Honors Director; developed workshop exchanges between students and local professionals; and chaired University endowment committees, among other leadership activities.

I personally value the opportunities that ACSA provides for its members and would like nothing more than to be able to contribute to the continued success and development of such an important organization. To this end, I hope you'll consider my candidacy as ACSA Secretary.
