Candidate Statement

Architectural design and education hold untapped potential to transform the world we inhabit into a more ecologically sound, socially just, and supportive place. As educators, we guide students as they develop insights and incubate creativity on the way to imagining a holistically sustainable future. We help expand students' knowledge and work with them as they hone technical skills and develop abilities to innovate. We guide students as they become members of the design and architecture community. Architects, as a result of our detailed understanding of the role of the environment and its design, can offer much to improve quality of life and well-being when we join members of ever broader communities of inter-reliant contributors. We take in and re-imagine the world around us with particular sensitivities that are beneficial to a host of interdisciplinary explorations of what is and what could be. At the same time, it is our responsibility to ensure that students conceive of their community of responsibility, to borrow from Aldo Leopold's Land Ethic, as comprehensive of all people as well as natural systems and resources. Every day, my students demonstrate their openness and enthusiasm for this responsibility. My optimism about architecture and its role in advancing an inclusive and sustainable future grows from almost 40 years in the field and more than 25 years as an architectural educator. I have witnessed undreamed-of transformations and believe our field's encouraging trajectory is poised to accelerate.

As the organization representing over 200 member schools and more than 5,000 architecture faculty, ACSA takes the lead in creating opportunities to advance architectural education and research and in helping nurture the abilities and promise within our students. Through the committee structure outlined in ACSA's 2016-2019 Strategic Plan, the organization has made significant progress in responding to the numerous challenges of its leading role in architectural education. We must continue to assess what supports faculty need at myriad institutions with diverse academic cultures and approaches to the education of future architects. Likewise, there is unfinished work to develop



resources and programs that will assist schools and faculty to engage and nurture the creative spirit of the full breadth of our students in ways that ensure all students know their ideas are valued and they are welcome as future professionals.

I served ACSA as the inaugural Chair of the Education Committee following its recasting in ACSA's 2016 – 2019 Strategic Plan. Under my leadership the committee made substantial progress in identifying and analyzing exemplary partnerships between community college programs and accredited architecture programs. We increased ACSA's dialog with the Consortium of Community College Architecture Programs (CCCAP). We also led sessions at the 2016 ACSA Administrators Conference and the 2017 Annual Meeting to identify challenges, opportunities, and best practices to diversify the pipeline into architectural education, support diverse architecture students, and grow and retain more diverse architecture faculties. I am excited to continue working with Mike Monti and the ACSA staff, ACSA Board members, committee members, and Faculty Councilors to enhance current support for faculty and member schools by providing a range of resources that will encourage multiple definitions of excellence.

I am confident that my previous service to ACSA as Education Committee Chair along with my academic accomplishments and experiences, my work with allied organizations like EDRA and ARCC, and my contributions to the AIA-ACSA Design + Health Consortium have prepared me to serve in the role of President. I am eager to identify opportunities to strengthen existing ties with collaterals, NAAB, NCARB, AIA and AIAS and other architecturally-focused organizations like CCCAP and NOMA and NOMAS and to build new bridges to organizations that may become our partners in interdisciplinary initiatives to address the complex challenges that confront societies around the globe. It is through such partnerships that we can realize the possibilities that the field of architecture offers.

We are poised to lead the charge for a more equitable, socially just, and ecologically sound world and to help others image a world rich with possibilities for future generations. As we advance in that direction, it would be my honor to serve ACSA and each of its constituent parts as president of the organization. I thank you in advance for your support.

Candidate Statement

It is an honor to be nominated as a candidate for ACSA second vice president. Serving as chair of the new ACSA Leadership Committee in its inaugural 2016–2017 term was significant to my perception of the potential role of ACSA's leadership in the advancement of architecture education and research. As co-chair for the upcoming 2018 Annual Meeting, *The Ethical Imperative*, in Denver, I am impressed with the wide scope of earnest and thoughtful participation from faculty members who are willing to assist the organization's members and talented staff by serving as session moderators, paper reviewers, project reviewers, and panelists. Early in my academic career I was assisted by comparable teams of people, and therefore I am eager to similarly give back by offering a four year commitment to serve ACSA in the role of second vice president, tracking to first vice president and president.

EXPERIENCE: My experience as an architecture pedagogue for 18 years paired with my time as Associate Dean for Research and Academic Affairs at Auburn University's College of Architecture, Design and Construction has afforded me a broad perspective of issues facing university administrators and professors in the research enterprise and undergraduate/graduate academic context. Our college offers 11 degree programs as well as Rural Studio, Urban Studio and Study Abroad, and this spectrum has afforded me the ability to both promote interdisciplinary endeavors and to provide momentum to discipline specific lines of inquiry. This work continues to inform my current teaching endeavors in upper level architecture studios, architecture history/theory and representation seminars, and interior architecture thesis.

CHANGES: Substantial changes developed by the ACSA Board leadership and staff for ACSA over the past three years are admirable and have brought the organization to a position of renewed strength. With the advent of the three committee structure and adoption of the ACSA Strategic Plan by the Board, ACSA is clearly in transition from its traditional role as a service organization to a more strategic role



as a leadership and advocacy organization. These changes allow for a broader range of participatory governance from interested faculty members. Leadership, Research/Scholarship, and Education committees allow a precise structure to assist the Board in forwarding the strategic plan charges including strengthening recruiting efforts, advancing diversity in schools and in the profession, while establishing recognition of value for architecture and its allied disciplines and professions.

PATH: Beginning with my attendance at the first ACSA Board and Committee Summit in Washington D.C. in 2016, I have been fortunate over the past year to repeatedly be in the presence of progressive leaders in architectural education and research. It is clear that these individuals are willing to volunteer time to ACSA because of strong beliefs in the role of pedagogy and research towards advancing culture and providing solutions to tough local, regional and global problems. Expertise paired with conviction developed over years of experience in the academic environment is channeled and directed at the ACSA organizational level as multiple voices solve larger order challenges that may benefit member schools.

These challenges are collective and include the need to increase diversity and inclusion, the need to increase recruitment and retention of competitive students into our programs and practice, and the importance of promoting quality peer-review venues for developing innovative teaching, research and creative work. As an invaluable resource, ACSA continues to expand its ability to share valuable enrollment data, salary, research, and program specific statistics. Continuation of effective and targeted partnerships between ACSA and the AIA, NCARB, NAAB and AIAS is important to the promotion of architecture and its allied disciplines. Strength in these organizational relationships between the "five collaterals" allows for our disciplines to develop support networks in industry and professional venues, and is foundational for collaboration with partners outside of the design disciplines.

LEADERSHIP COMMITTEE: The ACSA Leadership Committee offered an open discussion session at the 2016 Administrators Conference in Chicago on establishing the value of architecture education and research to others outside of the discipline. This was followed by a session in Detroit at the Annual Meeting focused on positioning the relationship and opportunities for architecture within existing STEM education and research initiatives. Related to recruitment, the committee worked to assist StudyArchitecture promotion and launch the centralized application service (ArchCAS) to streamline application into graduate programs at member schools. My continuation as Leadership Committee chair for 2017–2018 has allowed continuity as we develop our new charges from the Board to focus on advancing ACSA's international engagement and strategizing issues of recruitment for architecture and related disciplines offered by ACSA schools. In Denver please join us for a panel focused on international engagement.

Thank you for your consideration of my candidacy for second vice president. I welcome this continued contribution to ACSA through participation in ongoing efforts with the Board, Committee members, ACSA staff and members.

Candidate Statement

One of my graduate students recently asked me, *what made you interested in architecture*? This is a question that most of us regularly ask our students, but rarely ask ourselves. As I pondered my answer, I realized that the seven-minute walk from my school at the Don Bosco Institute to my father's hardware store in the heart of Alexandria, Egypt, was where it all started. During that walk, which I usually stretched to an hour or more, I meandered through his clients' workshops, manufacturing facilities, and industrial plants. Later, driven by a sense of curiosity and an abundance of hand and power tools, I developed a deep sense of affirmation and understanding for the relationship between tools, making, and craftsmanship.

Since my formal pursuit of architectural education that began almost twenty-five years ago, I have lived, studied, and worked on nearly every continent. These diverse and rich experiences (notably, developing a deeper understanding of the two primary schools of thought in two different countries, the Beaux-Arts and the Bauhaus) broadened my outlook and prepared me to live as a citizen of the world within the architectural design studio. Ultimately, I offer the notion of a universal citizen as a testament to how different cultures can come together to create a beautiful work of architecture.

The recent governance changes within ACSA, which address geographic hurdles in communication, transparency, and the connection between intentions and outcomes, affirms this ideal and convinced me to seek a seat on the board. The move from a location-based service to a diverse, international structure definitely broadens the organization's mission and strengthens its ability to lead and advocate for the betterment of architectural education. More than ever, and especially in this era of divisiveness, I stand inclusively with all my colleagues from all schools of architecture. As an international faculty member, I understand, and am an advocate for, enhancing the diversity and international climate in architecture. After all, the different—indeed, unique—paths that led each of us to our current roles are



reflected in our numerous and diverse contributions to the profession. Given that the ACSA represents over 5,000 architecture faculty and more than 300 supporting members, I believe that my ideas, experience, and background would help position the organization at the center of the ever-evolving discourses on education, research, practice, and civic engagement in the designed, and constructed environment.

I have learned from architectural practice, and in particular from campus planning that a successful master plan always starts with a good strategic plan. Candidate Statement


I presented my first ACSA paper in 1996, at an international conference in Copenhagen. It was a thrill. Since then I've practiced and taught in several ACSA regions: the Northeast (at CCNY and Columbia GSAPP in New York, and the BAC in Boston), the West (University of Utah in Salt Lake City, and in Los Angeles), and the Mid-Atlantic (Georgia Tech in Atlanta). I am excited about the potential of the "at-large" Director format, which might allow me to draw on these cross-regional connections and experiences, and to forge new ones, in advancing ACSA's strategic plan. It was the change in Board format that inspired me to seek the nomination.

Some of the strategic themes I am particularly enthusiastic about furthering, should I be elected to serve on the Board of Directors, include:

DIVERSITY & EQUITY

The ACSA Board plays a significant role in gathering and sharing good data, and in disseminating effective practices for achieving equitable opportunities and increasing diversity on many fronts: in our committee rooms, classrooms, and, ultimately, in design offices and on jobsites. To design well for our communities, we should look – and be – more like our communities. How do we conduct the most effective outreach efforts on this front?

- Increasing equity and furthering diversity are important themes in my own 20+ years of teaching, scholarly research, consulting practice, and advocacy work towards retrofitting suburban form and designing better suburban futures.
- I've been fortunate to teach for the past decade at one of the most truly diverse professional architecture schools in North America, the Bernard and Anne Spitzer School of Architecture at The City College of New York, in West Harlem. In 2015, almost half of our student body came from underpresented minority groups (as I learned while drafting and editing our school's NAAB Architecture Program Report).



• Let's work harder together to find the best and brightest from all corners to bring into the discipline's fold – and promote their inclusion at all levels.

URBANISM & COLLATERALS

The world's population is becoming more urbanized and less rural; the forms of global urbanization have become ever more complex and interlinked; and the catastrophes of climate change are wreaking cumulative havoc. Is it not *vital* that ASCA and member schools work together with AIA, NCARB, NAAB and AIAS to advance deeper knowledge among architects about these complex processes and their effects?

- Urbanism, especially in the context of sustainability and resilience, is a significant front for multidisciplinary STEM collaborations and funded research opportunities for faculty.
- I would advocate for ACSA's work with our collateral organizations to promote increased knowledge of urbanism within architectural education.

PROMOTION & TENURE

I am heartened by the recent ACSA white paper on tenure and promotion. There is need for greater clarity "up the chain" to deans and top administrators to best explain and advocate for the somewhat unique models of scholarship in architecture, especially design scholarship. Conversely, is there more that ACSA can do to assist architecture faculty in producing the conventionally recognized and disseminated markers of peer-review and recognition?

My personal experience with publishing and peer-reviewing for an array of urban planning journals could be put to good use in helping to develop
proposals for improving the tracking and recognition of scholarship by architecture faculty.

Candidate Statement

Schools of architecture are tightly connected to two rapidly-changing contexts: the academic environment and the professional world. Both these contexts are marked by specific shifts that we must carefully take into account. Within academia, some of these transformations include, for example, the necessity to supplement decreasing public funding; the emphasis on efficiency and production that call for research that can yield measurable outputs; the increasing demands on faculty regarding administration, research and teaching; or even the imperative to adapt to new ways of learning, and communicating. With respect to the profession, the education that we offer our students must cover the diversification of architectural practice in realms that range through single buildings, landscape, urbanism and infrastructure; it must provide students with the technical and critical abilities that enables them to judiciously integrate newer and older ways of drawing, modelling, fabricating and building; we must, as always, comply with the professional requirement and maintain our status as accredited programs; and we must be aware of the critical issues of our times, from the ecological to the political crises, through economic and social imbalances both locally and globally.

The world is constantly changing, and seemingly changing at an increasing rate, and so do the university and the profession. A crucial question is to address how, as Schools of Architecture – within an academic and professional context – we are able to question ourselves on the one hand, but also, position ourselves on the other. As educators, professionals and above all, free thinkers, we must respond to these shifting conditions with curiosity, openness, deference in some cases and resistance in other. I am fundamentally interested in discussing and understanding how architectural education remains relevant in shifting contexts, while collectively reflecting upon how we maintain academic freedom and protect our ability to think freely in our contemporary world.

Candidate Statement

Having practiced and taught in diverse contexts in at least 3 continents, I believe my contribution to the ACSA may be able to take into consideration a wide range of distinct ways of addressing the relevance of architectural education in relation to different communities and modes of practice. In a time when conversations about the necessity to establish a continuum flow between education and practice are much desired, I am hoping to be able to bring a useful and diverse contribution to educating future architects in and for a greater diversity of physical, social, economic and cultural contexts and communities.

In Lisbon, just after graduating from a 5-year architectural professional programme, I was fortunate enough to work at UTOPOS, a Lisbon architectural studio, with Maria Manuel Godinho de Almeida, who graduated from Yale and Duarte Cabral de Mello, who had worked in the 1970's at the IAUS, and was one of the founders and editors of Oppositions. That exposure to a rather different way of understanding the role of architectural research and debate was crucial, as it set up the path for me to want to learn more about architectural criticism, that lead me to go to the Bartlett School to do a Masters in History of Modern Architecture and study under Adrian Forty and Ian Borden.

In London, I learned to appreciate and value the unique studio and school culture of the AA and the Bartlett, where teaching and learning emphasized the role of process and of documenting the architectural (re)search students were doing whilst developing their curiosity and design work. This intricate link between research and (as) design also seemed to have a great parallel with the relationship between architectural criticism and architectural practice. Both schools in London were unique as they seemed a mosaic of ideas, with faculty and students from completely different cultural and social backgrounds. This was indeed different from my Lisbon school experience, as most professors and students were from the same school and city. I recall reflecting about how would it be possible for a school to nurture



and promote such a multitude of creative potential and possibilities. Reviews emphasized opportunities for unique debates centred on the students' work and the issues raised by the projects. Schools are and can be creative architectural hubs where people with very different backgrounds generously, creatively and critically share and discuss values, concerns, ideas and spatial and tectonic propositions to contribute to change how we think and conceive the past / present / future as a desirable spectrum.

In Macau, I was extremely fortunate to work with Manuel Vicente, who had studied with Louis Kahn in the 1960's. Manuel Vicente was, at the time, an emeritus professor at Hong Kong University. He introduced me to Eric Lye, the HKU director, who later on invited me to teach design studios in 1995. HKU had that very same intensity and diversity within its' community. These experiences in the office as well at the studio made it quite clear that our pedagogical role as leaders, whilst working with and on other people's work is a rather crucial one as it may help directly or indirectly set up the path for unknown futures, just as it happened to me in Lisbon.

Later on, my teaching experience in the US, both in Minneapolis and in Arlington, somehow contributed to the possibility to consider schools as a unique cross section or an intersection between theory, criticism and practice, research and design, ideas and communities.

At Dalhousie, some of the contributions I have introduced were to promote a greater interaction between and within the courses, a strong emphasis on understanding and documenting the design process, and research as design. These have the objective to provoke and promote a greater understanding by everyone, professors and students, about the holistic nature of architecture as a project and how it is crucial for professors and students to appreciate and celebrate how their research and design processes are profoundly intertwined with each other.

I have been able to maintain my practice CVDB ARQUITECTOS based in Lisbon, Portugal, while teaching, and since I have been the director at the School of Architecture at Dalhousie University. We have always understood our architectural work, that has fortunately had national and international recognition, as part of a larger physical and cultural landscape, that considers both the individual's and collective experiences and perceptions of spaces and places. With this we hope to establish a possibility for an understanding of the architectural work to be socially, economically, culturally relevant and resilient in its different contexts and communities.

If elected to the ACSA Board, it will be an honour to serve and to contribute with the other board members to continue to explore and expand the role of architectural education, research and work within our multiple and diverse communities.
