FRANCES BRONET | Opening Keynote

Frances Bronet became Pratt Institute's 12th president on January 2, 2018. Before coming to Pratt, Bronet, a distinguished educator and leader at the forefront of interdisciplinary learning, served as senior vice president and provost at Illinois Institute of Technology (IIT) in Chicago. Previously, she served as acting provost at the University of Oregon; before that she was the dean of the School of Architecture and Allied Arts (now the College of Design). Bronet began her academic career as a faculty member in the School of Architecture at Rensselaer Polytechnic Institute. She also held positions of associate dean of architecture, professor of architecture, and acting dean of the School. Bronet is past president of the Association of Collegiate Schools of Architecture (ACSA), past chancellor for the ACSA College of Distinguished Professors, and currently on the Executive Board of the Association of Independent Colleges of Art and Design (AICAD). She is the co-founder of the ACSA Women's Leadership Council.

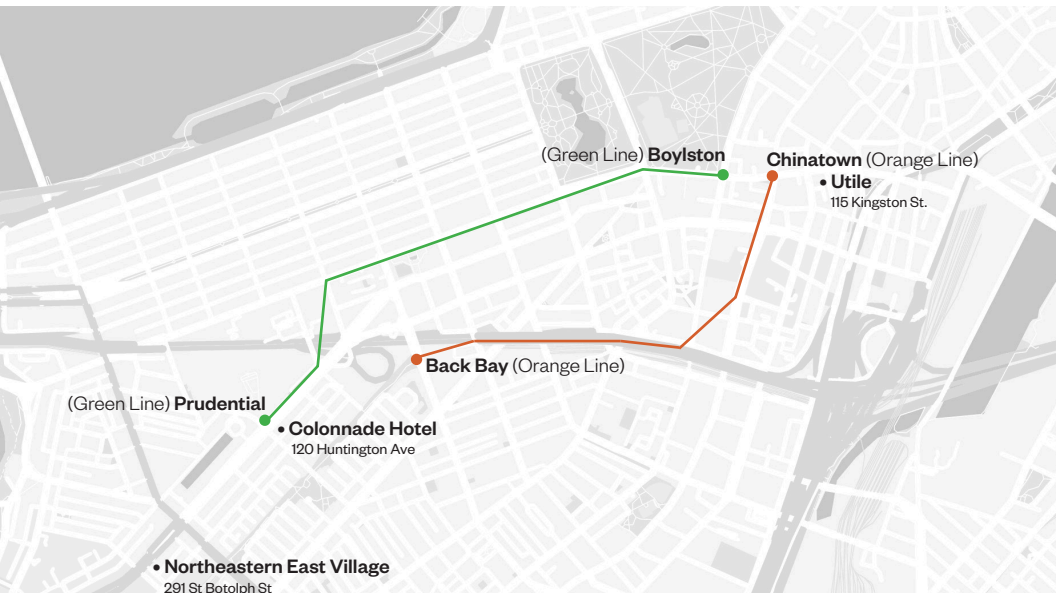
